**This Prospectus Supplement**

This prospectus supplement (the "**Prospectus Supplement**") to the base prospectus dated 30 September 2021 (the "**Original Base Prospectus**") prepared by Marex Financial as Issuer under the programme for the issuance of warrants, notes and certificates with respect to the Securities (the "**Programme**"), constitutes a supplement to the Original Base Prospectus for the purposes of Article 23(1) of Regulation (EU) 2017/1129 (as amended, the "**EU Prospectus Regulation**"). The Prospectus Supplement should be read in conjunction with Prospectus Supplement No. 1 to the Original Base Prospectus dated 28 January 2022 and Prospectus Supplement No. 2 to the Original Base Prospectus dated 3 June 2022 (the Original Base Prospectus as so supplemented, the "**Base Prospectus**"). On 30 September 2021, the Commission de Surveillance du Secteur Financier (the "**CSSF**") approved the Original Base Prospectus for the purposes of Article 6 of the Luxembourg Law dated 16 July 2019 on prospectuses for securities.

Terms defined in the Base Prospectus have the same meaning when used in this Prospectus Supplement unless otherwise defined herein. This Prospectus Supplement shall form part of and be read in conjunction with the Base Prospectus.

**Right of withdrawal**

In accordance with Article 23(2) of the EU Prospectus Regulation, investors in the European Economic Area who have already agreed to purchase or subscribe for Securities issued under the Programme before this Prospectus Supplement is published and where the Securities have not yet been delivered to them at the time when the significant new factor, material mistake or material inaccuracy to which this Prospectus Supplement relates, arose or was noted, where the Securities are affected by the significant new factor, material mistake or material inaccuracy to which this Prospectus Supplement relates, have the right, exercisable until 4 October 2022, which is three working days after the publication of this Prospectus Supplement, to withdraw their acceptances. Investors may contact the relevant Authorised Offeror(s) (as set out in the Final Terms of the relevant Securities) should they wish to exercise such right of withdrawal.

**Responsibility**

Marex Financial accepts responsibility for the information given in this Prospectus Supplement and confirms that, having taken all reasonable care to ensure that such is the case, the information contained in this Prospectus Supplement is, to the best of its knowledge, in accordance with the facts and does not omit anything likely to affect its import.

**Purpose of this Prospectus Supplement**

The purpose of this supplement is to extend the offer period of the Securities and make corresponding changes to the final terms dated the relevant date as specified in the Schedule (each, the "**Final Terms**" relating to the relevant Securities specified in the Schedule). **This Prospectus Supplement supplements the Base Prospectus only in relation to the Securities specified in the Schedule and shall only amend information in the relevant Final Terms for such Securities.**

## Information being supplemented

"An offer of the Certificates may be made by the Issuer or any offeror other than pursuant to Article 1(4) of the Prospectus Regulation in the respective Public Offer Jurisdiction during the period commencing on (and including) the date on which the Certificates are admitted to trading on the EuroTLX market and ending on the Final Reference Date at the latest."

#### **3. Amendment to the issue specific summary of the Securities of each Final Terms:**

*In section 4 under "Under which conditions and timetable can the Investor invest in the Security?" the first paragraph contained in subsection "General terms, conditions and expected timetable of the offer" of each such Final Terms shall be replaced as follows:*

"Terms and conditions of the offer: An offer of the Securities may be made by the Issuer and/or any offeror other than pursuant to Article 1(4) of the Prospectus Regulation in the Public Offer Jurisdictions during the period commencing on (and including) the date on which the Certificates are admitted to trading on the EuroTLX market and ending on the Final Reference Date at the latest (the **"Offer Period"**)."

**Interpretation**

To the extent that there is any inconsistency between (a) any statement in this Prospectus Supplement and (b) any other statement in or incorporated by reference into the Base Prospectus, the statements in (a) above will prevail.

References to the Base Prospectus shall hereafter mean the Base Prospectus as supplemented by this Prospectus Supplement.
